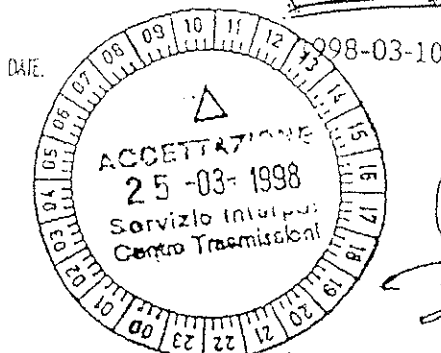

On 10 February 1997 a letter was directed to Dott Andrea Grassi of Direzione Centrale Polizia Criminale, Servizio Centrale Operativo, Roma by the Presidential Investigation Task Unit, South African Police Service, Cape Town.

The mentioned unit was tasked with the investigation of a certain Vito Roberto Palazzolo.

This unit acted irregularly and incorrectly in directing the request directly to the addressee without using the Interpol channels.

Furthermore, the unit is under investigation for having committed certain offences, both criminal and departmental.

It would be appreciated if the original request forwarded by the Presidential Investigation Task Unit could be obtained and forwarded to this NCB for evidential purposes.

It is also requested that your NCB should inform the Italian law enforcement agencies that all requests for assistance from the South African Police Service should be directed via the Interpol channel for the purposes of proper co-ordination and control.

A copy of the letter mentioned above is enclosed for your information.

This matter was also discussed with Mr Basilio Montone of your office, during his recent visit to South Africa on 1998-02-23.
